Notice is hereby given that Voltalia UK Ltd, ("the Company") with company registration number 07489990, having its registered office at The Wheelhouse, Bond's Mill Estate, Stonehouse, Gloucestershire, England, GL10 3RF has applied to the Scottish Ministers for consent under section 36 of the Electricity Act 1989 to construct and operate a ground mounted solar photovoltaic (PV) development, Battery Energy Storage System (BESS), associated infrastructure, access, and landscaping at Springfield Farm (Central Grid Reference 74514 71531). The installed capacity of the proposed Solar PV generating station would be up to approximately 165 MW, and the BESS would have an installed capacity of up to approximately 80 MW. The proposed development is subject to Environmental Impact Assessment (EIA) and an EIA Report has been produced.

The Company has also requested a direction under section 57(2) of the Town and Country Planning (Scotland) Act 1997 that planning permission for the development be deemed to be granted.
